ORDER:

In the reference 2<sup>nd</sup> read above, the Hon'ble Minister for Agriculture and Cooperation has requested to sanction funds for construction of a Mega Church at Nizamabad under Special Development Funds.

After careful examination of the matter, the Government hereby accord Administrative Sanction for an amount of Rs.4,00,00,000/- (Rupees four crore only) as Grant-in-aid for Construction of Mega Church (CSI) at Nizamabad in relaxation of the orders issued vide G.O. 1<sup>st</sup> read above, as a Special Case.

3. The Managing Director, Telangana State Christian (Minorities) Finance Corporation, Hyderabad is hereby requested to release the amount sanctioned at Para-(2) above, to the District Collector, Nizamabad subject to obtaining all the required proposals from the District Collector, Nizamabad as per the existing guidelines, before releasing the funds.

4. The above amount shall be debited to the Head of Account Head of Account "Repairs and Maintenance of Churches and Burial Grounds" under the Head of Account "2225 - 80 - 190 - 25 - 06 - 310 - 312".

5. The Director, Minorities Welfare/the Managing Director, Telangana State Christian (Minorities) Finance Corporation shall take necessary action accordingly.

6. The District Collector, Nizamabad is requested to comply with the orders issued in the reference 1<sup>st</sup> read above, and incur the amounts duly following procedure prescribed and send Utilization Certificate to Government without fail.
