5. The Director, Minorities Welfare, Telangana State, Hyderabad and the Managing Director, Telangana State Christian (Minorities) Finance Corporation, Hyderabad shall take necessary action accordingly.

6. The District Collector, Karimnagar is requested to comply with the orders issued in the G.O. 1st read above, and incur the amount for which the sanction is accorded and send Utilization Certificates to the Government.
