ORDER:

In the references 6th read above, the District Collector, Nizamabad has submitted a proposal for sanction of Grant-In-Aid for construction of Community Hall to Christian Minorities in Yellareddy Mandal Head Quarter, Nizamabad District, **since the same is as per the Assurance of the Hon'ble Chief Minister.**

After careful examination of the matter, the Government hereby accord Administrative Sanction for an amount of Rs.1.10 Crore (Rupees one crore and ten lakh only) as Grant-in-aid towards construction of Community Hall to Christian Minorities in Yellareddy Mandal Head Quarter, Nizamabad District, **as a Special Case in relaxation of the orders issued vide references 1st & 2nd read above.**

3. The Managing Director, Telangana State Christian (Minorities) Finance Corporation, Hyderabad is requested to release sanctioned amount in Para-(2) above to the District Collector, Nizamabad District.

4. The above amount shall be debited to the Head of Account Head of Account "Repairs and Maintenance of Churches and Burial Grounds" under the Head of Account "2225 -80 – 800 – GH – 11 - SH (32) 270 – Minor works – 272-Maintenance" .

5. The Director, Minorities Welfare/the Managing Director, Telangana State Christian (Minorities) Finance Corporation shall take necessary action accordingly.
