In the G.O. 1<sup>st</sup> cited, Government have assigned certain new schemes for financial assistance to Christian Minority Community for their development.

- 2. The Managing Director, A.P. State Christian (Minorities) Finance Corporation, Hyderabad in the reference  $2^{nd}$  cited, has sent proposals for inclusion of a new scheme i.e. a Training Programme for Law Graduates belonging to Christian Minorities in Administration of Justice to the existing schemes in the above G.O.
- 3. Government, after examination of the proposal, have included the Scheme of "Training Programme for Law Graduates belonging to Christian Minorities in Administration of Justice" as 26<sup>th</sup> scheme in addition to the existing schemes vide G.O. 3<sup>rd</sup> cited.
- 4. Now, Government issue the following guidelines and eligibility criteria for implementing the scheme of "Training Programme for Law Graduates belonging to Christian Minorities in Administration of Justice".

#### **GUIDELINES:**

1. The number of candidates for the Training of Law Graduates initially shall be 20 candidates per year – 4 candidates for High Court of Andhra Pradesh and 16 candidates for the District/Lower courts for a period of 3 years

- 2. The seats shall be allocated prorata District wise Christian Population as per 2011 census.
  - 3. The period of training for the Administration of Justice shall be 3 years and Andhra Pradesh High Court calendar year shall be followed.
  - 4. The stipend per candidate is Rs. 1,000/- per mensem
  - 5. A yearly allowance of Rs. 6,000/- is admissible for purchase of Advocate's Coat, Gown, Bands, Books, Office Furniture, Bar Council enrolment fees, Library Fees, etc.
  - 6. An amount of Rs. 2,000/- per candidate per annum, is set aside for the candidate under training for Administration of Justice, for attending seminars, workshops, symposiums etc., that enhances advocacy skills of the candidate.

- 7. Presently, this scheme is centralized and the selections are made at State level in the State Office.
- 8. The selected candidates shall be attached to the offices of Law Officers in the Andhra Pradesh High Court and District Courts, preferably dealing with the subjects of Home, Revenue, Municipalities, Services, Welfare etc., in conjunction with the Advocate General's office.
- 9. Adequate publicity will be given inviting applications for the training of the Law Graduates on Administration of Justice, through press releases from the State Office and the District Offices.

## Eligibility Criteria:

- 1. The training program shall be for Law Graduates belonging to Christian Minority Community, proof of record viz. School records, Revenue Records, any Govt. Records etc, shall be submitted.
- 2. Income Limit of the Parent/Guardian not exceeding Rs. 2.00 Lakhs or as notified by the Government from time to time.
- 3. Enrolment/Registration with the Bar Council of India/State Bar Council of Andhra Pradesh.
- 4. Written/Oral Examination conducted by the State Officer or Agency designated by Government.
- 5. The Managing Director, A.P State Christian (Minorities) Finance Corporation, Hyderabad is therefore, requested to take necessary action accordingly for implementing the Scheme.
