ORDER:

The Government of Telangana is keenly interested in the Social, Educational and Economic development and Welfare of Minorities in the State, and it is noticed that there is a felt need for opening number of Residential Schools for the Educational upliftment of the Minority community.

- 2. In the reference read above, the Government have sanctioned one residential School and one Post Matric Hostel per District, i.e., ten (10) Residential Schools & ten (10) Post Matric Hostels in the State.
- Government after careful examination of the matter and considering the need hereby accord Administrative Sanction for (60) more Minorities Residential Schools, totally 70 Residential Schools in the state to be located at the following locations:-

- 4. It is further ordered that Vice Chairman & Managing Director, Telangana State Minorities Finance Corporation shall take action to register the Telangana Minority Residential Educational Institutions Society as its Secretary on the same lines as TSWRES immediately. All the Minorities Residential Schools shall be under the control and administered by this Society. The Secretary shall take advance action for identification of rented buildings initially and recruitment of Staff for the School through T.S.P.S.C., and ensure that all the Seventy Residential Schools become operational from June, 2016. Simultaneously, Secretary, T.M.R.E.I.S., shall also take steps to identify land within two Months for construction of permanent buildings and furnish proposals to Government for sanctioning the same.
- 5. All other necessary arrangements to make all the Schools operational shall be done by the Secretary, T.M.R.E.I.S., immediately.
- 6. Further, Secretary, T.M.R.E.I.S., shall also circulate proposals immediately for recruitment of various categories of staff required by each school and also requirement of funds. Separate orders for allocation of funds and sanction of staff will be issued through Finance Department shortly.
- This orders issues with the concurrence of Finance (HRM.II) Department, vide their U.O.No.809-B/17/A1/HRM-II/2016, dated 23-01-2016.
- 8. The Vice Chairman and Managing Director, Telangana State Minorities Finance Corporation, Hyderabad shall take further necessary action immediately.
